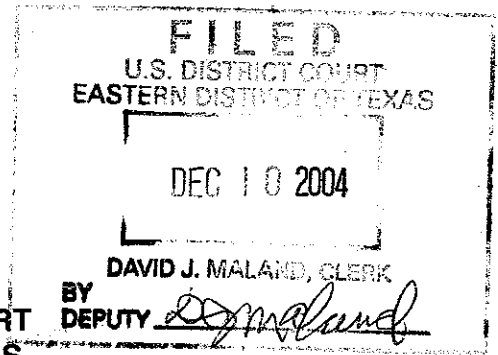


General Order No. 04-27
