GENERAL ORDER TRANSFERRING CASES**

3. Reassign or refer, as appropriate, every other pending case and each closed case with a pending motion or other matter currently assigned to Magistrate Judge Johnson to Magistrate Judge Bill Davis, and
4. Refer the pending § 2255 habeas cases listed on Attachment A that are currently referred to Magistrate Judge Aileen Goldman Durrett to Magistrate Judge Bill Davis.
