**GENERAL ORDER ASSIGNING CIVIL AND CRIMINAL ACTIONS**

In accordance with 28 U.S.C. § 137 and the agreement of the judges affected hereby, it is ORDERED that, effective Thursday, March 2, 2006, all civil and criminal cases filed shall be assigned to individual judges of this district in the proportions listed below:

CHIEF JUDGE THAD HEARTFIELD	Civil = 34% of Beaumont, 35% of Lufkin Criminal = same as civil
JUDGE RICHARD A. SCHELL	Civil = 50% of Sherman Criminal = 40% of Sherman
JUDGE DAVID FOLSOM	Civil = 90% of Texarkana, 20% of Marshall Criminal = 100% of Texarkana
JUDGE T. JOHN WARD	Civil = 60% of Marshall, 10% of Texarkana Criminal = 100% of Marshall
JUDGE LEONARD DAVIS	Civil = 25% of Tyler, 20% of Marshall Criminal = 50% of Tyler
JUDGE RON CLARK	Civil = 27% of Beaumont, 65% of Lufkin Criminal = 33% of Beaumont, 65% of Lufkin
JUDGE MARCIA CRONE	Civil = 39% of Beaumont Criminal = 33% of Beaumont
JUDGE MICHAEL SCHNEIDER	Civil = 25% of Tyler, 20% of Sherman Criminal = 50% of Tyler, 40% of Sherman
SENIOR JUDGE WILLIAM M. STEGER	Civil = 50% of Tyler

SENIOR JUDGE PAUL BROWN

Civil = 30% of Sherman  
Criminal = 20% of Sherman

It is hereby ORDERED that all civil cases assigned to Judge William M. Steger prior to February 16, 2006<sup>1</sup> are hereby TRANSFERRED and RESTORED to his docket, except for the following:
