ORDER OF WITHDRAWAL OF REFERENCE AND
SCHEDULING ORDER FOR NON-JURY BANKRUPTCY CASES L. HARRIS, CLERK

It is ORDERED that, effective January 1, 1988, the reference to the Bankruptcy Judge is hereby withdrawn and the cases on the list attached hereto are referred to the Honorable Judith K. Guthrie, United States Magistrate, for proceedings under 28 U.S.C. 636(b)(1)(B) or if the parties consent to trial of the case before a United States Magistrate, under 28 U.S.C. 636(c)(1)(3). It is further

ORDERED that Status Conferences will be held at 10:00 o'clock p.m. on February 3, 1988, in the United States District Courtroom, Lufkin, Texas, and counsel shall be present. It is further ORDERED that:

1. These cases will be set for trial in March 1988 at the status conference.

2. Counsel are required to meet prior to the Status Conference and make a good faith attempt to resolve pending motions.

3. Motions to join additional parties shall be filed by January 15, 1988.

4. All discovery shall be concluded by March 1, 1988.


5. No amended pleadings shall be filed after the status conference.

6. A written status report containing the following information shall be filed by January 25, 1988:

- a. A list of pending motions requiring a ruling together with a certification that counsel have met and were unable to resolve the dispute.
- b. A statement of the issues involved.
- c. A statement of disputed facts and law.
- d. In the event of a dispute as to legal issues, counsel shall submit a brief with the status report.
- e. Counsel shall be prepared to accurately estimate the time required for trial of the adversary proceeding.

7. All filings shall be in the Tyler Division.
