GENERAL ORDER RE-APPOINTING PART-TIME MAGISTRATE

The term of office of the Honorable Charles L. Attaway, part-time United States Magistrate for the Texarkana Division, Texarkana, Texas, being due to expire on January 1, 1990, and

The Judicial Conference of the United States, having voted to continue the part-time magistrate position at Texarkana for an additional four-year term of office,

In accordance with the 1979 amendments to the Federal Magistrates Act, 28 U.S.C. Section 631, et sequi, and the 1980 regulations of the Judicial Conference, promulgated under authority of 28 U.S.C. Section 631 (b) (5), a Notice of Appointment of Panel to Consider Reappointment of United States Magistrate was published, a panel of citizens to consider the reappointment of Magistrate Charles L. Attaway was appointed by General Order of the Court dated November 2, 1989, and

The panel met, reviewed the incumbent's current service as magistrate, invited comments from members of the bar and public and other evidence of the incumbent's good character, ability and commitment to equal justice under the law and reported to the Court, unreservedly recommending the reappointment of Charles L. Attaway as part-time United States Magistrate.

WHEREFORE, in accordance with the authority conferred by 28 U.S.C. Section 631, et sequi, and the further authority granted and action taken by the Judicial Conference of the United States

in its 1980 regulations, and following the unanimous vote of the judges of this Court, it is hereby

ORDERED that the Honorable Charles L. Attaway of Texarkana, Texas, is hereby reappointed part-time United States Magistrate at the salary as fixed by the Judicial Conference of the United States, with his official station being Texarkana, Texas.


The Honorable Charles L. Attaway shall enter upon the performance of his duties at 12:01 a.m. on January 2, 1990, but prior to the commencement of such duties shall take the oath or affirmation prescribed by sections 453 and 631 (f) of Title 28, U.S.C. He shall serve as part-time United States Magistrate and discharge the duties of said office for a term of four (4) years from January 2, 1990, unless sooner removed, subject to the provisions of Section 631 (c) of Title 28 U.S.C.

All General Orders heretofore entered and not rescinded by the Court conferring powers and duties upon the Magistrate shall be in full force and effect and are adopted herein.

The Clerk will cause certified copies of this order to be spread upon the records of the several divisions of this Court and shall likewise forward a certified copy of said order to the Director of the Administrative Office of the United States Courts as required by section 631 (g) of Title 28 U.S.C.
